OFFICE MEMORANDUM

Subject:- Revision of rates of Pension Contribution Payable during foreign service.

The undersigned is directed to invite a reference to this Ministry's O.M. No. F.1(10)-E.III(B)/66 dated the 17th April 1967 on the subject mentioned above and to state that the question of revising the rates of Pension contribution payable by Central Government employees during active period of their foreign service (with reference to PR 115 & 116) has been under consideration for some time as many changes have taken place including the revision of scales of pay of Central Government employees on the basis of the recommendations of the Third Pay Commission. The President is pleased to decide that the rates of Pension Contribution shown in Annexure to the above said O.M. will stand revised as in the Annexure to this O.M. These revised rates shall be chargeable on the maximum monthly pay of the post in the substantive/officiating grade as the case may be, held by the officer at the time of proceeding on foreign service.

2. The revised rates will take effect from 1-7-1982.
3. In so far as the employees of the Indian Audit and Accounts Department are concerned, this O.M. has been issued in consultation with the Comptroller and Auditor General of India.
