The month of December, 2021 saw an downward trend in the States' monthly fiscal assets as compared to November, 2021. The daily fiscal assets of the States at the end of the month of November, 2021 was Rs. 3,08,255.17crore, whereas at the end of the month of December, 2021 the daily fiscal assets of the States was Rs. 2,68,594.61crore.
