

Monthly Summary Report of January,2022

I Financial Position of States

The month of January, 2022 saw an upward trend in the States' monthly fiscal assets as compared to December, 2021. The daily fiscal assets of the States at the end of the month of December, 2021 was Rs. 2,68,594.61 crore, whereas at the end of the month of January, 2022 the daily fiscal assets of the States was Rs. 3,15,540.05 crore.

During January, 2022, a total of Rs. 1,223.77 crore was released as Additional Central Assistance for Externally Aided Projects (EAPs) to States as per the details given in the table below:

Consent of Open Market Borrowing (OMB) and Negotiated Loan allowed to the States:

Department of Expenditure, Ministry of Finance follows the fiscal limits inter-alia mandated by approved recommendations of Finance Commissions through the powers to approve borrowings by States under Article 293(3) of the Constitution of India.

During the month of January, 2022, Government of India consent of Rs. 2,14,069.00 crore was issued to States under Article 293(3) of the Constitution of India for raising Open Market Borrowing (OMB) for the remaining period of FY 2021-22 and Government of India consent of Rs. 150.00 crore was issued to the State of Goa under Article 293(3) of the Constitution of India for raising negotiated loan.

Additional Borrowing linked to performance in power sector:

Ministry of Finance, based on the recommendations of the 15th Finance Commission, has decided to grant additional borrowing space of upto 0.5 percent of the Gross State Domestic Product (GSDP) to the States every year for a four year period from 2021-22 to 2024-25 based on reform undertaken by the States in the power sector.

During the month of January, 2022, additional borrowing permission of Rs. 7,309.00 crore was issued to two States for undertaking the stipulated reforms in power sector. While, Rajasthan has been allowed to borrow additional Rs. 5,186.00 crore, Andhra Pradesh has been allowed to borrow additional Rs. 2,123.00 crore as incentive to embark on the reform process.

During the month of January, 2022, as per the recommendations of the 15th Finance Commission, a total of Rs. 12,187.36 crore was released to the States as per the details given in Table.

In addition, a sum of Rs. 95,082.00 crore was released by Department of Economic Affairs as share of Central taxes and duties to State during the month of January, 2022.

Special Assistance to States for Capital Expenditure for 2021-22: Capital Expenditure amounting to Rs. 8,865.64 crore has been approved for the States of Assam, Bihar, Chhattisgarh, Goa, Gujarat, Haryana, Himachal Pradesh, Jharkhand, Karnataka, Madhya Pradesh, Maharashtra, Manipur, Meghalaya, Mizoram, Nagaland, Odisha Punjab, Rajasthan, Sikkim, Telangana, Uttar Pradesh and West Bengal under the Scheme of 'Special Assistance to States for Capital Expenditure: 2021-22' and an amount of Rs. 5,191.860 crore has been released to the States up to the month of January, 2022. Further, out of Rs. 8,865.64 crore approved amounts and Rs. 5191.860 crore released amounts under the Scheme, an amount of Rs. Rs. 249.00 crore has been approved and released towards additional allocation under the Scheme to the State of Rajasthan.

The State Government of Madhya Pradesh has submitted a proposal for availing incentives provided for privatising State Public Sector Enterprises (SPSEs) under Part-III of the Scheme. After examining the proposal, an amount of Rs. 518.17 crore was approved as Special Assistance (Loan) to Madhya Pradesh under Part-III of the Scheme and the 1st instalment amounting to Rs. 259.085 crore has been released to the State.
